Replacement Vehicle Coverage

In case of a Road Accident to the Insured Vehicle, provided that such an accident is covered under the Motor Insurance Policy terms & conditions, and if it requires more than 24 hours to repair (as certified in a written form by the repairer) AMAN ASHARQ will provide the insured with a REPLACEMENT VEHICLE from a Rent A Car Company only for the duration of the repairs and subject to the maximum number of days.

In any case, AMAN ASHARQ Cover for Replacement Vehicle is subject to the following terms & conditions:

1. The Geographical coverage area is restricted to U.A.E and the overlapping territories of Oman.
2. The Replacement Vehicle is given only for the duration of the repairs but subject to the maximum number of days.
3. The period of Replacement will not be extended due to delay in repairs. However, should the Insured require an extension for any reason whatsoever, then such an extension will be at an additional cost to be paid by the insured.
4. The repair works and Replacement Vehicle have to be arranged and authorized by Al Sagr National Insurance Co. Claims Department.
5. The Replacement Vehicle is for the exclusive use of the Insured or an authorized driver having a valid U.A.E Driving License and must not be given to any third person.
6. The Insured Person shall be responsible for the cost of fuel during the rental and for any Traffic Offense committed during the rental period. ABNIC/AA will not be responsible for any Fines and Traffic Offenses whatsoever.
7. The Replacement Vehicle should be returned by the insured at the end of the Replacement period covered by Aman Asharq to the Rent A Car Company. If kept for a longer period, the insured will pay all additional rental charges.
8. The insured must receive and return the Replacement Vehicle at the Rent A Car Company premises.
9. The Replacement Vehicle cover is not available for normal service and checkups. and for immobilization caused by any malfunctioning or breakdown of the Insured Vehicle.
10. The Insured is liable to pay excess fees for any fault accidents subject to the terms & conditions of the Rent A Car Company.
